

Croxby Primary Academy - Pupil premium strategy statement

Part A: Pupil premium strategy plan 2021-2024

Statement of intent

The academy draws on research evidence (such as the Education Endowment Foundation toolkit – see Appendix 1) and evidence from our own experience to allocate funding to activities that are most likely to maximise achievement. We never confuse eligibility for the Pupil Premium with low ability and focus on supporting our disadvantaged students to achieve the highest levels. Our Pupil Premium and Recovery spend is divided into 3 areas: Quality First Teaching; Targeted Support and Wider Strategies.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Disadvantaged children have gaps in their maths, English and Foundation subject knowledge due to being significantly less likely to have come from a rich home learning environment.
2	On entry to EYFS, 66% of children are below age related expectations in Prime Areas. Specific significant gaps in moving and handling and writing.
3	Lower attendance figures and higher persistent absenteeism of disadvantaged children.
4	Limited life experiences, travel and learning outside the immediate community and reduced learning motivations as a result of low aspirations.
5	Increasing parental engagement with their children's learning and the academy.

Intended outcomes

This explains the outcomes we are aiming for **by the end of our current strategy plan**, and how we will measure whether they have been achieved.

To provide an EYFS curriculum which is highly effective, and which ensures children are engaged in their work and play and sustain high levels of concentration. Children, including those children from disadvantaged backgrounds, will do well.

Across all parts of the provision, practitioners' interactions with children are of a high quality and contribute well to delivering the curriculum.

The number of disadvantaged children in EYFS who achieve GLD will be above 60%

Activity in this academic year

This details how we intend to spend our pupil premium (and recovery premium funding) this academic year to address the challenges listed above.

Quality First Teaching (for example, CPD, recruitment and retention)

Spending on improving teaching might include professional development, training and support for early career teachers and recruitment and retention. Ensuring an effective teacher is in front of every class, and that every teacher is supported to keep improving, is the key ingredient of a successful academy and should rightly be the top priority for Pupil Premium spending.

Targeted academic support (for example, tutoring, one-to-one support structured interventions)

Evidence consistently shows the positive impact that targeted academic support can have, including on those who are not making good progress across the spectrum of achievement. Considering how classroom teachers and teaching assistants can provide targeted academic support, including how to link structured one-to-one or small group intervention to classroom teaching, is likely to be a key component of an effective Pupil Premium strategy.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2021 to 2022 academic year.

Quality first teaching			
Impact	Lessons Learned		
 As a result of coaching and team teaching, the number of teachers 'demonstrating an effective quality of education' increased from 89% to 100% by the end of the year. Academy MER shows a reduction in numbers of teachers getting 'no' (no evidence seen during drop ins) when areas are reviewed across the school. In the two EYFS Deep Dives, all areas were achieved by all staff. In Phonics there were 3 areas not achieved in September, this reduced to 0 in in March. A Deep Dive looking at the lowest 20% of readers showed all areas from all staff to be achieved. Maths started strongly in October with only 4 areas not achieved and this reduced to 2 in May. There was an increase in the number of disadvantaged pupils achieving GLD at the end of EYFS from 60% in 2019 to 75%, as a result of QFT. In the Year 4 multiplication test, 100% of Disadvantaged pupils achieved at least 20 and 45% achieved full marks. At the end of KS1 there was an increase in the percentage of disadvantaged pupils achieving the expected and greater depth standard in the last five years in reading, writing and maths.

gap in KS2 between the percentage of disadvantaged pupils and non-disadvantaged pupils achieving the expected standard in reading has decreased from 31% in term 2 to 6% at the end of the year.

- The KS1 Disadvantaged pupil outcomes for reading increased from 56% in 2019 to 71%.
- Disadvantage children who had Yipiyap preteaching in maths increased their scores by an average of 25% compared to non-disadvantaged.

YIPiYAP tutoring will continue to have a Maths focus and staff will be asked to consider disadvantaged pupils as a priority.

There is a high number of disadvantaged pupils in Year 6 this year and therefore an additional HLTA and TA will support in this year groups every morning. There will also be an additional teacher for reading lessons in Year 6 to create smaller focus groups.

In the afternoons, pre-teach Maths sessions will support progress in Maths and disadvantaged pupils will be a focus for this.

Wider Strategies

Impact

- Attendance figures for this year for disadvantaged pupils was 92% which is below last year's at 94% and lower than non-DA for this year which was 94%.
- The percentage of Persistent Absentees in school was 6.% this academic year, which was below the target of 7%. The percentage of PAs who were Disadvantaged was 39% by the end of this year, which was a significant decrease from last academic year when it was 62%
- All pupils in school accessed NAPA musical theatre lessons during at least one term of the academic year. Performances were uploaded to youtube to encourage parental engagement.
- All EYFS and KS1 pupils put on a Christmas performance which was recorded for parents to watch online.
- All KS2 pupils received either ukulele or glockenspiel weekly lessons, delivered by the LA's School Music Service through the year.
- 25% of the eligible DA children participated in the school musical.
- 19% of pupils who attended an activity club were disadvantaged.
- Through supported funding all disadvantaged Year 6 pupils participated in the end of year visit.
- Virtual visits were carried out for all pupils to access where possible. These included a session with a poet for all KS2 pupils, a virtual Jorvik visit for Year 3 pupils, an online visitor to talk about the Romans for Year 5 pupils and the Year 6 pupils accessed learning about the Holocaust from an online visitor.

Lessons Learned

Continue to offer enrichment opportunities to all children in the academy and look at where this can be developed further (trips/visitors/sports opportunities)

Activity Clubs to be offered at lunchtimes as well as after school to enable more children to attend if they wish, including more Disadvantaged pupils.

Assistant Head for Personal Development Behaviour and Welfare to work with the attendance officer to continue to work with families to reduce the number of PAs – this to be reported on head-line measures.

New EWO appointed for the West who will meet with school welfare staff to discuss what they can offer re support for attendance this year.

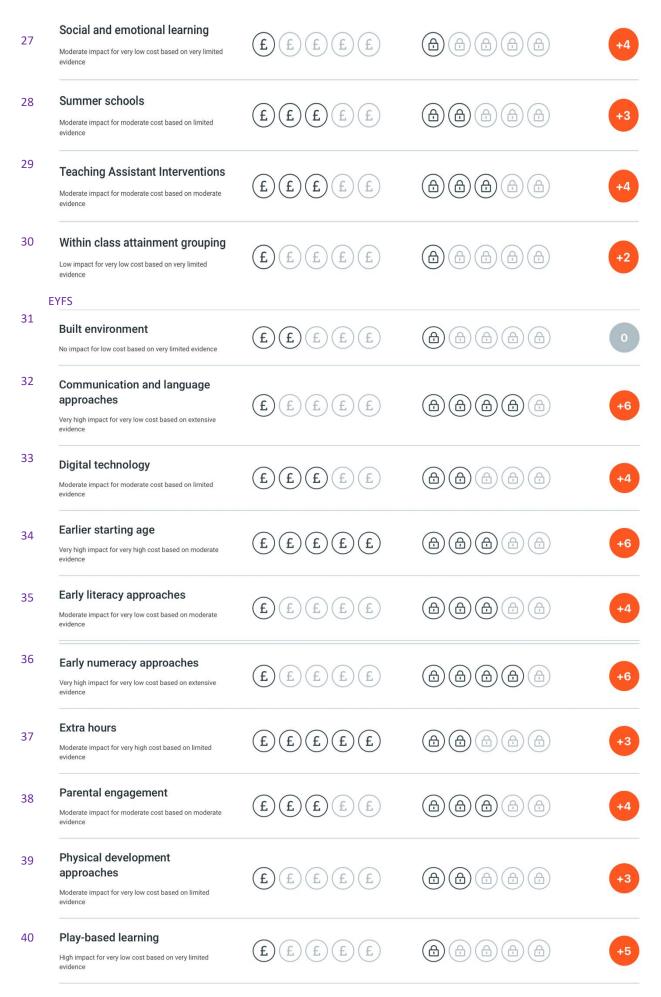
Appendix 1 Education Endowment Foundation (EEF) - Pupil Premium Toolkit
